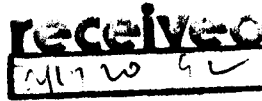

nice summer vacation.

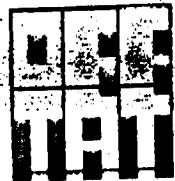

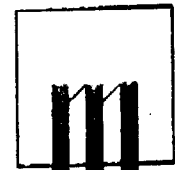

Requirements for Showing of *Tokyo Four* by Steina

DESCRIPTION: Steina's *Tokyo Four* is really a video wall — a four-channel synchronous video matrix installation, with four audio channels, i.e. four speakers. It needs an acoustically isolated space of its own. The length of the showing is 22 minutes. It can be programmed for continuous playback, playback on demand, or playback on a regular timetable as you wish.

EQUIPMENT:

- 9 large matching stackable monitors
- 4 audio channels (2 x stereo) speakers
- 4 laser disc players or 4 3/4 inch U-matic NTSC tape players. (We provide tapes or discs and a synchronizer for either format.)

FEE: A base fee of \$5,500 USD is required depending on the amount of equipment you provide. If we provide the monitors and players the fee will be substantially increased. The fee is also variable depending on the duration of the exhibit.
