VIDEO: A RETROSPECTIVE/LONG BEACH MUSEUM OF ART 1974-1984 September 9 - November 4. Opening festivities on Sunday afternoon, September 9, 2-4pm. Selected video works, exhibited at the Long Beach Museum of Art since 1974, will be presented in a series of programs. The exhibition, together with the publication of a catalogue, documents LBMA's role in the development of video on the West Coast. Supported in part by the National Endowment for the Arts and the California Arts Council.

CONCEPTS IN CONSTRUCTION: 1910-1980

September 9 - November 4.

This exhibition surveys major tendencies in constructivist art of the 20th century. Curated by historian Irving Sandler, approximately 60 works are presented including paintings, sculpture, drawings and prints. Artists represented include: Lissitzky, Malevich, Moholy-Nagy, Mondrian, Held, Judd, LeWitt, Rickey and Stella. The exhibition was organized by Independent Curators Incorporated.

## NEWS FROM THE VIDEO COUNCIL

Dear Video Council Member;

The Long Beach Museum of Art is undergoing tremendous change. Months of complex negotiations culminated, in July, with the signing of a first ever contract between the two-year old LBMA Foundation and the City of Long Beach. The Foundation has initiated a search for an Executive Director by naming a selection committee: Jim Ramo, Al Martin, Joe Krause, myself and chaired by Judith Luther. When the terms of the contract are met the Executive Director will become Director of the Musem.

The video Council named a preservation committee: Bill Viola, Vicki Whiting, Kira Perov, myself and chaired by Jude Jansen. This committee is intent upon providing for "state-ofthe-art" conservation of and access to our most important and valuable asset, the video art Archive.

The video Council's cable committee: Bruce Yonemoto, Stuart Bender, Bill Viola, ex-officio Joe Leonardi and chaired by Branda Miller guides policy for our programming now seen in Palos Verdes, Seal Beach and Long Beach. This committee is researching an international networking system as well as future presentation of videotapes from the Archive. The Governing Board of the Video Council welcomes Jude Jansen, in-coming vice chairperson, and Jerry Wellman, member-at-large. Jude is currently consulting for AFI and Jerry is a preparator of exhibitions at LAICA.

Halfway into 1984 the Video Council finds itself with clear goals and expanded responsibilities. We meet the second Wednesday of every month, 7:30 pm at the Station/Annex. Everyone is welcome. Our role in the future of video art is pivotal. We need your support and involvement.
